Long-time members of League could be forgiven for having a sense of déjà vu as they participated in the January 12 "Lively Issues" meeting, held for the purpose of identifying concerns to be addressed in future League work. Suggested issues like managing the spread of manure to protect water quality, recycling, poverty, and reproductive rights have consumed

hundreds of League hours, at least during the 40 years I've been a member. And water quality! That has been one of the primary issues for this League since its organization in the 1950's.

I remember one memorable activity when members took a day-long tour of all the county's municipal sewage treatment systems. Then there was the recycling curriculum we developed for the schools. Working in coalition with the county's other dedicated environmental organizations to support clean water resulted in a survey of every private onsite wastewater treatment systems (POWTS), otherwise known as septic systems and holding tanks, as well as a mandatory procedure to monitor future systems. The list goes on.

Because we still have problems in these areas mean we have failed? Not at all. As we learned with a recent Supreme Court decision, important issues require continued scrutiny and stewardship. Laws change, technology develops, and circumstances evolve. As a review of all those old League scrapbooks demonstrates, Door County's attempt to protect its drinking water has always been important and on the radar. And there is still much work to be done.

Newer issues such as broadband and universal internet access; the growing demographic challenge of enough caregivers for the aging population; affordable and sustainable housing; affordable, available childcare; and, of course, the perennial challenges to voting rights were also identified. And there were others you'll hear more about as planning proceeds.



Local candidate forums to be held



Sister Bay Candidate Forum: On February 15, the League will host a primary candidate forum for the seven Sister Bay Village Trustee candidates whose names will appear on the February 21 primary ballot. The forum will be at the Sister Bay Fire Station (2258 Mill Road, Sister Bay) from 6:30 -8:00 PM. One candidate will be eliminated. Town of Nasewaupee Candidate Forum: The League has been asked to host a candidate forum In March for the six candidates who will be running for three town board seats in the April election. A date has not been set yet.



A seat on the Wisconsin Supreme Court is on the ballot of the February 21 primary. Sometimes referred to as SCOWI, this is the state's highest court. It's responsible for determining if laws violate the Wisconsin Constitution. It also establishes and enforces rules and codes of conduct for Wisconsin attorneys, judges, and the justices themselves. The court is located in Madison.

The court is made up of seven justices who serve 10-year terms. One of those seats is up for election. There are four candidates running for the seat. The two candidates who receive the most votes in the primary election will advance to the spring election on April 4.

Why does this matter? The Wisconsin Supreme Court makes decisions that affect us all. Their rulings can decide voting rights, reproductive rights, economic development, educational policy and more. While the justices serve 10-year terms, the impact of their decisions can last even longer.

This program will provide a snapshot of the health and wellness of Door County middle and high school students using data from the 2021 Youth Risk Behavior Survey. It will also explore services and programs that provide support to Door County's young people, their families, and schools.

Panelists will include

- <u>Public Health Educator Shauna Blackledge</u>, who will present the results of the 2021 Youth Risk Behavior Survey.
- <u>United Way Community Impact Coordinator of Health Cami Peggar</u>, who will present the STRIDE Program. This Door County Collaborative School Mental Health Project is a United Way program created in 2018 to remove barriers to accessing quality mental health care for Door County youth. The collaborative offers on-site mental health services in all five Door County school districts.
- <u>Juvenile Diversion Program Coordinator Kelsey Christianson</u> will present the county's Juvenile Diversion Program.
- School Resource Officer (SRO) from one of the Door County Schools who will explain the SRO Program in our mainland schools.

YOU can help improve League's social media reach

Think about it. Facebook and Instagram are big businesses. Both platforms exist due to their advertising revenue. They exist because so many of us spend hours upon hours viewing posts and videos.

What does the LWV-DC do to increase the number of viewers our posts receive?

We "boost" a few posts each month. When we "boost" posts (or advertise), we're also targeting demographics, which includes having an interest in social and political issues, philanthropy, travel, or even a location like Door County. When we specify the traits and pay for the boost, we increase our chances of engagement. This happens whenever someone "likes" or reacts to a boosted post or clicks through an advertisement.

What else can we do to increase the number of views?

We can concentrate on creating better posts. Posts that receive the greatest number of views almost always have excellent photography and more people. We'll be trying to photograph members and volunteers in action at events, forums, and educational seminars as well as outdoor events because we have such a beautiful county to use as a backdrop. Many popular posts also feature cute dogs and cats (I'm not kidding. Cute animals are excellent subjects!) and include clever or powerful text and great graphics. We'll be trying to capture key events because the more appealing the post, the more exciting or inspiring the topic, the more viewers we'll automatically receive. Why? Because Facebook and Instagram's *primary* goal is to give more people more of the things they want to see more of the time.

How can YOU impact our social media?

This one's easy. The more you "like," comment, and share *every* LWV post you see, whether it's the LWV, LWV Wisconsin or specifically LWV Door County, the more both platforms' algorithms will recognize those posts as more "popular" or engaging. When that happens, Facebook and Instagram's algorithms automatically show the post to *MORE* people with similar interests in the hope they will also engage with it. The boosting, combined with immediate engagement, is key to our success. So, if you haven't seen our posts, visit the LWV Door County page every so often and "like" the posts. Eventually, both Facebook and Instagram will notice you're interested and LWV Door County posts will be shown to you (and others) more often.

Welcome new members!

In this section, new members will introduce themselves. We want to get to know you! If you haven't sent us your short bio, please do.



Please welcome a recent newcomer to our membership, Virge Temme. She moved to Door County in 1997 after graduating from the University of Illinois School of Architecture. She grew up in central Illinois, the daughter of Virgil Tibbs, a general contractor who built pole barns and small homes and instilled in her the importance of political awareness. In fifth grade, she and her girlfriends would often reenact political debates at their sleepovers, right down to Nikita Khrushchev banging his shoe on the podium. Before moving to Door County, Virge led a nationwide study of Cold War architecture for the Army Corps of Engineers. For over five glorious years, her life involved crawling through ABM and Atlas missile sites and tromping up mountains to record Cold War Radome Antenna. In addition, she authored the history of our nation's two most extensive military family housing programs, Capehart and Wherry.

Upon moving to Sturgeon Bay, she opened her architectural practice, focusing on environmentally sound homes. In addition, she started Peninsula Pulse Green pages, formerly called "On the Green," which focused on sustainable architecture and lifestyles. In 2006, as a member of Sustain Door, she orchestrated the "100-Mile Food Challenge", a year-long challenge to eat primarily local foods, and the "50-Mile Feast" to bring awareness to local food producers.

In 2016 Virge became a general contractor, one of only three active female GCs in Wisconsin, building the homes she designed. She has developed and built some of the most energy-efficient homes and commercial buildings in Wisconsin and was presented with the United States Green Building Council "Women in Sustainability Leadership" award for her efforts in public awareness and mentorship in this field.

She currently sits on the state's Uniform Dwelling Code Council, encouraging it to improve building energy codes to reduce atmospheric CO2. Virge is currently transitioning from design-build to a retirement of research, gardening, reading, cooking, and enjoying good friends. She is looking forward to learning from and working with the other fine members of LWV to support the League's goal of empowering voters and defending our democracy, and we are delighted to have her onboard!
