## Message from the Chair:



## Who is Eileen Bohn?

This month's "Focus on Youth Mental Health" program on March 23 is the fifth event in the Eileen Bohn Speaker Series. Members might well ask, "Who is Eileen Bohn?" The inevitability of the passage of time means that with each year fewer of us remember Eileen, much less worked with her.

Eileen Bohn was a longtime member of the Door County League, moving here in the 60's and getting so involved that by the early 70's, she was president of the local chapter. Even decades later when health intervened, not allowing her to be as active, she was always a voice of reason, calmness, and wisdom. If I had had a speed dial on my phone,

Eileen's number would have been on it. During my years as president (and after), she was a constant resource for advice on applying the nonpartisan policy, applying League positions to action, or any of a variety of questions regarding how to apply League's strict standards for how to operate. I know others did the same. Her calm, cool, sensitive, and discerning intellect and temperament helped us parse sometimes hazardous political waters.

My favorite Eileen story illustrates the tremendous impact she had on Door County and our League:

"After the 1970 census, the Supreme Court ruled on reapportionment, citing the 'one man, one vote' rule. In Door County, League members monitored the redistricting that takes place every 10 years after the census and discovered that that standard was not applied locally. Eileen was president at the time, and the local League with the support of the LWV of WI challenged the County Board's redistricting plan. Although I did not witness it, I have often envisioned Eileen - a quiet, polite, unassuming lady with a steel backbone - standing before the County Board and threatening legal action if the Board did not redo their plan. I would so have loved to be a fly on the wall. As a former member of the Door County Board, I can only speculate at the reception she received.

*The Door County Advocate* of January 18, 1972, stated:

"In a letter to County Board Chairman Herbert Petersen, Mrs. Rodney Bohn wrote that the League hopes that within the next two months the county board will rescind its action and move to adopt a plan which conforms to the principle of equal representation. If this does not happen, it will be necessary for a citizen or the League to take appropriate court action."

A follow-up article on January 20 had these two quotes:

- "Haen's immediate reaction on hearing...was to utter a heartfelt (if slightly petulant) cry of, 'Must the League of Women Voters stick their nose in EVERYTHING the county does?'"
- "Weisgerber, on the other hand, faced the situation with equanimity...'Instead of stirring up a hornet's nest let's appoint a three-member committee to sit down with the ladies and talk this over.'"

A few months later on July 27, 1972, an article reports:

"Reapportionment of Door County's supervisory districts was challenged Thursday in a lawsuit filed in Circuit Court by the Sturgeon Bay chapter of the League of Women Voters. The chapter's suit asks that last April's election of 21 supervisors be declared invalid. It also calls for a new election in November."

## The case was settled out-of-court in League's favor!

When Eileen died in June 2016, her family generously donated money in her memory to establish the Eileen Bohn Speaker Fund. The fund was to be used to bring quality speakers to the county each year to speak on issues of importance to League. Eileen was very committed to a wide range of issues and worked hard over the years to promote good government. We are very grateful to her family for helping us continue that work.

Wheelchair transport and help with "curbside voting" are available. Request and arrange a time for curbside voting through your municipal clerk. ## **Observer Corps Update: Blending the Old with the New**

Observer Corps (OC) supports the League's mission to encourage informed and active participation in government. Our goal is to maintain a presence in as many government meetings as is possible and to utilize this information to facilitate our goals and work in the community.

We have a new model which encourages broader participation and have recently received Board approval for our revised policies and procedures.

#### The new model identifies two levels of participation:

- <u>Regular Observer</u>: chooses one body of government and attends in person, via Zoom, by watching past videos, and/or by reading minutes.
- <u>Occasional Observer</u>: follows one particular issue and attends when interests or concerns arise.

Documents from the OC orientation packet as well as important reference materials are <u>available here</u> our website.

It is critical that we track our attendance and report important information that may be used when issues arise or action is taken. On that webpage, in the third subheading, there is a link to the <u>OBSERVER CHECK-IN FORM</u>. This is the form we use to preserve that data. It populates a spreadsheet that will be used for committee and League work. **Observers, please fill it out**. (It only takes a few minutes!)

From that <u>same webpage</u> you can navigate to LMV POSITIONS on the left sidebar. From there, scroll down to NATIONAL and click and you will find the 158-page book, <u>LWV IMPACT ON ISSUES, A Guide to</u> <u>Public Policy Positions</u>. This neatly organized book is an essential reference manual for all Observer Corps and Action committee referrals. "The intention is to inspire Leagues to use national positions to act in their own communities" (Introduction, page 1).

League-related issues of concern are forwarded to the OC and Action Coordinators for review. Observers are encouraged to utilize the "Meeting Observation Form" when recording actionable referrals. (<u>GUIDES AND RESOURCES</u>) The action taken will be based on the above-mentioned League policies and positions. However, if none exists, we develop our own through a systematic approach of research and study; occasionally, the request may be referred back to the individual for community involvement.

In addition, on our web page, there is a copy of the 22/23 County Board Directory and a 2022 contact information for Door County Municipal Clerks. (<u>GUIDES AND RESOURCES</u>)

Observer Corps is more than "just observing"; it is also advocacy, accountability and activism--all essential elements for achieving a representative democracy that reflects the will of the people.
