### ***Sevastopol Town Supervisor Forum March 7, Upcoming Voter Registration Events***

**DOOR COUNTY, WI, February 19, 2024** – A video recording from the [League of Women Voters of Door County's](#) candidate forum for the Door County Circuit Court Branch 1 is [available on the LWV Door County YouTube channel](#).

Jennifer Moeller and Brett Reetz participated in the February 15 forum held at ADRC in Sturgeon Bay. The candidates were given equal opportunity to speak and respond to voter questions while offering the public an occasion to become informed and active participants in democracy and the election process. More than 90 people were in attendance.

Moeller and Reetz are vying for the seat of Door County Branch 1 Circuit Court Judge in the April 2 election.

During the 90-minute forum, candidates introduced themselves to voters, explained their reasons for running and responded to questions on several topics related to the work of the circuit court. Susan Kohout, LWVDC chair, moderated the forum.

### **Sevastopol Supervisor Candidates Forum March 7**

The next LWVDC candidate forum is scheduled for Wednesday, March 6, 6 – 7:30 p.m., Sevastopol Town Hall, 4528 WI-57, Sturgeon Bay.

Forum participants include all four candidates on the April 2 ballot to fill two supervisor seats on the Sevastopol Town Board. Mark Haberli and Trent Olsen are challenging incumbents Jeanne Vogel and Derek Denil. The event is free and open to the public and offers candidates equal time to present credentials and answer questions.

LWVDC wants to ensure Door County residents are ready to vote in 2024 elections. Residents can update their registration, check voter status or register for the first time at the following locations:

- Thursday, March 7, 11:30 a.m. – 1 p.m., Door County ADRC, 916 N. 14<sup>th</sup> Ave., Sturgeon Bay (ongoing, first Thursday of the month)
- Saturday, March 9, 11 a.m. – 1 p.m., YMCA, 1900 Michigan St., Sturgeon Bay
- Monday, March 11, 5 p.m. – 7 p.m., YMCA, 1900 Michigan St., Sturgeon Bay
- Tuesday, March 12, 11 a.m. – 1 p.m., Northwest Wisconsin Technical College, 229 N. 14<sup>th</sup> Ave, Sturgeon Bay
- Wednesday, March 13, 11 a.m. - 1 p.m., Northeast Wisconsin Technical College, 2834 S. Bay Shore Rd., Sister Bay

New or updated voter registration might be necessary if someone moved, had a name change, recently became a U.S. citizen, or did not vote in the past four years. The deadline to register for the April 2 election is March 13.

Elections in 2024 are scheduled as follows: February 20, spring primary; April 2, spring election and presidential primary; August 13, partisan primary; and November 5, general election. Learn more at [myvote.wi.gov](https://myvote.wi.gov).
