This program is for members as well as the public. It will have two parts: First, an overview of the history and structure of local government will provide background on how this level of government works in Door County. Second, members will explain the League's Observer Corps and tell of their past experiences. ## Assistance, free rides to the polls and to Municipal Clerks available

The League is collaborating with the Door County Transportation Department to help anyone in the county who needs transportation to accomplish the tasks of <u>registering to vote</u>, <u>voting early</u>, <u>or delivering their absentee ballot to their municipal clerk or voting in person at their <u>polling place</u> for election on November 8.</u>

Voters can contact Transportation Manager Pam Busch at (920)746-6944 or <a href="mailto:pbusch@co.door.wi.us">pbusch@co.door.wi.us</a> to arrange a free ride to their municipal clerk to register, vote early, or drop off an absentee ballot or to the polls to vote on election day.

Wheelchair transport and help with "curbside voting" are available. Request and arrange a time for curbside voting through your municipal clerk. # Message from the Chair: Nonpartisanship in a hyper-partisan world

We live in challenging political times – as individuals and as League members. Perhaps you receive as many questions about League's nonpartisan status as I do. If so, I offer a reprint of an article I wrote last year for the newsletter. I hope it aids in framing answers to the many questioners who don't understand how our policy applies in the many activities League is engaged in.

#### Nonpartisan, but politically active – How does that work?

The League of Women Voters never supports or opposes any political party or candidate. It is, therefore, nonpartisan.

However, it is also a political organization of women and men dedicated to encouraging and promoting good government through informed, active participation in all levels of democracy local, state, and national. That means studying and acting on any and all studied issues that impact our nation, our state, and our communities.

Oxymoron? Not really. Recently the League was criticized for being an advocate on issues, suggesting that made it partisan. Remember those 102 years of studies that led to positions on topics? Those documented positions inform whether the League supports or opposes an issue and form the basis of the actions that are taken. The resulting advocacy has nothing to do with whether these positions are currently espoused by the Republican, Democratic, Green, Libertarian, or whatever other party may exist at the time.

Case in point: League has lobbied for redistricting reform in Wisconsin for many decades. And frankly, they were no more successful in convincing previous Democratic administrations to adopt an independent non-partisan commission to draw our maps than they have been in convincing recent Republican legislatures. League's position on the issue has not changed. Only the party in power that is resistant to this reform has changed.

So yes, League is nonpartisan - both in its approach to elections and in its approach to advocacy. Both are crucial to its mission!

## **MH/SU Committee**

<u>The Education Committee</u> has met with local officials to learn about restorative justice. Members, along with the Legislative Committee, observed the Criminal Justice Coordinating Committee to learn more. The county is proposing a Bullying/Harassment Ordinance that can be used as a Diversion Court tool, and the League is supporting it at County Board on Oct. 25. Excerpt from that statement is below:

<u>The Legislative Committee</u> is preparing items for advocacy with the governor and legislature for inclusion in the 2023-2025 biennial budget. It is also reviewing four state constitutional amendments that passed last term. If they pass early in the next term, they will appear on the ballot in April.

#### **Excerpt from statement to County Board 10-25-22**

As many of you know, the League has been involved in a multi-year study of the systems in Door County that serve people dealing with mental health and/or substance use either in their own lives or as family members or friends. As part of that project, we have been following the county's work through its committees and this board. Throughout the study process and our current advocacy efforts, we have been impressed by the continuing efforts of county and community leaders to develop strategies and tools to improve outcomes for people dealing with mental health and/or substance use issues and other challenges including involvement in the criminal justice system.

The League advocates based on positions it has developed by a process of study and member agreement. It has long advocated for appropriate alternatives to incarceration and other strategies that can promote rehabilitation and responsible reentry into community life. As such we strongly support such county programs as the Door County Treatment Court and the Juvenile and Adult Diversion programs. We applied and thank those of you who have worked to put them in place.

Our monitoring efforts have brought the Bullying/Harassment Ordinance proposal on your agenda this morning to our attention. It is our understanding and belief that the availability of such an ordinance can provide an additional tool for use in the Diversion programs to encourage participation in strategies which use the principles of Restorative Justice to promote healing for victims as well as offenders. We support these efforts and urge you to adopt this ordinance.
